Pursuant to the lockdowns imposed by the Central and State Government authorities since March 24,2020 to contain the spread of COVID-19 outbreak, the Company's operations were closed which gradually resumed in a phased manner with requisite precautions and complete operations at other unit could be resumed in April, 2020. Accordingly results for nine months period ended on December 31,2020 are not comparable to corresponding previous nine months period ended on December 31,2019. The company has taken into account the possible impact of COVID-19 in preparation of the unaudited financial results; including its assessment of recoverable value of its assets based on internal and external information up to the date of approval of these unaudited financial results and current indicators of future economic conditions. The railways were not fully operationl; the demand for new coaches and rolling stock was reduced in the current Financial Year. The delievery period for current order book has been rescheduled by Railways With the beggining of next Financial year the railways are expected to be fully operational and we are optimistic that in the coming financial year, the demand for new coaches as well as rolling stock will be good as per the data released by the Ministry of Railways.
